2. Brief Description	<p>This Project specifically addresses APPOGG’s priorities by identifying those groups that are at risk of social exclusion and targets them for intervention. Moreover, it is meant to upgrade the skills of those who are responsible to facilitate the integration of people at risk of social exclusion into gainful occupation.</p> <p>The objectives of this Project are: This Project is meant to achieve a measured increase in employability of persons at risk of social exclusion as well as assist them in the achievement of gainful occupation. It is also meant to increase the participation of persons in the labour market through the scaling up of qualifications and assistance to retain employment. Such training and employment would provide the individual with a real and rewarding job and the dignity and security that accompanies employment.</p> <p>The activities within this Project will be the following: Various training programmes with staff will be conducted, particularly in foster care, issues involving children and youths who have been sexually, physically or mentally abused, community services, social welfare service, etc..</p> <p>This Project involves also training of staff involved in the training of ex-drug and alcohol addicted people in employability skills and to support them in employment. This Project aims to set up a resource centre for managers and operators in the social sector to support people at risk of social exclusion. Another activity involved is Job Placement co-ordination.</p>
